

**Response to Tribunal request regarding Gao Zhisheng**

## **An open invitation by Gao Zhisheng to the Canadian international independent investigation team**

◁Upon hearing the forming of an independent investigation team by the former Canadian Asia and Pacific Division chief Mr David Kilgour and the internationally renowned human rights lawyer Mr David Matas to investigate the claim that some mainland Falun Gong followers had their organs removed and were killed, mainland human rights lawyer Mr Gao Zhisheng expressed his respect for them and sent out an invitation to the investigation team. Mr Gao invited the former Canadian senior official and the renowned lawyer to go to the mainland to investigate the truth behind the persecution of Falun Gong followers and stated that he would try all he could to assist this investigation. Following is a written account of what Mr Gao said. ▷

Dear Messrs David Kilgour and David Matas,

As all my telephones and networks have been cut off, I can only communicate through reporters and the media. I wish to express my sincere respect to you for your protection of and care for human justice. Also, as a mainland member of the CIPFG, I extend a verbal invitation to you.
